BILL

1 AN ACT concerning
 2 Maryland-National Capital Park and Planning Commission Capital Budget for
 3 Fiscal Year 2003-2004 and Capital Improvement Program
 4 For Fiscal Years 2004-2009

5 For the purpose of amending the Prince George's County portion of the Maryland-National
 6 Capital Park and Planning Commission Capital Budget for Fiscal Year 2003-2004 and Capital
 7 Improvement Program for Fiscal Years 2000-2005 to add one new development project in the
 8 Commission's Capital Improvement Program.

9 WHEREAS, Article 28, Section 2-118 (b) of the Annotated Code of Maryland provides for
 10 the amendment of the Capital Budget and Capital Improvement Program of the Maryland-
 11 National Capital Park and Planning Commission by the County Governing Body on its own
 12 initiative or at the request of the Commission and after public hearing upon reasonable notice to
 13 the public; and

14 WHEREAS, an amendment to the Prince George's County portion of the Maryland-
 15 National Capital Park and Planning Commission's Capital Budget for Fiscal Year 2003-2004
 16 adopted by CB-32-2003, and Capital Improvement Program for Fiscal Year 2000-2005, as
 17 adopted by CB-32-2003, is proposed to include the addition of one development project; and

18 WHEREAS, the development project is the Bowie Civic Auditorium project; and

19 WHEREAS, the County Executive's recommendation was solicited and received; and

20 WHEREAS, the County Council has conducted a public hearing on the proposed
 21 amendment having given reasonable notice thereof; now therefore,

1 SECTION 1. BE IT ENACTED by the County Council of Prince George's County,
2 Maryland, that the Prince George's County portion of the Maryland-National Capital Park and
3 Planning Commission's Capital Improvement Program for Fiscal Years 2003-2004, as adopted
4 by CB-32-2003, is hereby amended to include the project as shown in Exhibit A attached hereto
5 and made a part thereof.

6 SECTION 2. BE IT FURTHER ENACTED that this Act shall take effect forty-five (45)
7 calendar days after it becomes law.
