WHEREAS	Article 28, Section 2-118 (b) of the Annotated Code of Maryland provides for

initiative or at the	request of the Commission and after public hearing upon reasonable notice to
the public; and	
WHEREAS	an amendment to the Prince George's County portion of the Maryland-
National Capital	Park and Planning Commission's Capital Budget for Fiscal Year 2003-2004
adopted by CB-32	2-2003, and Capital Improvement Program for Fiscal Year 2000-2005, as
adopted by CB-32	2-2003, is proposed to include the addition of one development project; and
WHEREAS	the development project is the Bowie Civic Auditorium project; and
WHEREAS	the County Executive's recommendation was solicited and received; and
WHEREAS	the County Council has conducted a public hearing on the proposed
amendment havin	g given reasonable notice thereof; now therefore,

1	SECTION 1. BE IT ENACTED by the County Council of Prince George's County,	
2	Maryland, that the Prince George's County portion of the Maryland-National Capital Park and	
3	Planning Commission's Capital Improvement Program for Fiscal Years 2003-2004, as adopted	
4	by CB-32-2003, is hereby amended to include the project as shown in Exhibit A attached hereto	
5	and made a part thereof.	
6	SECTION 2. BE IT FURTHER ENACTED that this Act shall take effect forty-five (45)	
7	calendar days after it becomes law.
