Howard W. Stone, Director of the Government Operations and Fiscal Policy Committee, provided a verbal report of the actions and recommendations of the Committee of the Whole.

The legislation proposes to reclassify certain class titles and grades, restructure certain class series and add classes of work as a result of organizational studies conducted by the Office of Human Resources Management (OHRM). OHRM determined that the Security Officer, Electrician and the Heating, Ventilation and Air Conditioning Technician classes of work need to be reallocated to higher grades to be more competitive and support the County's goal of attracting and retaining qualified applicants. Additionally, OHRM is recommending changes in two (2) class series titles for the Paralegal Assistant and Police Records Manager, to accurately reflect the positions.
