**RESOLUTION**

A RESOLUTION concerning

Schedule of Fees

FOR the purpose of amending certain fees in the County Onsite Sewage Disposal Regulations.

WHEREAS, Section 22-101.1, as enacted by CB-11-1985, of the Prince George's County Code provides that the fees applicable to the provisions of Subtitle 22, "Onsite Sewage Disposal Systems", shall be designated by the Health Officer and subject to approval by Resolution of the Board of Health; and

WHEREAS, the Health Officer has designated and presented to

the Board of Health certain amendments to the Schedule of Fees;

NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's County, Maryland, that the Schedule of Fees for Subtitle 22, Onsite Sewage Disposal Systems, as adopted by CR-136-1985, and last amended by CR-54-1991, be amended as follows:
