Maryland-National Capital Park and Planning Commission				

For the purpose of amending certain revenues and expenditures in the Approved Maryland-National Capital Park and Planning Commission's Annual Budget for Fiscal Year 2010.

WHEREAS, the Annual Budget and Appropriations Ordinance for Fiscal Year 2010 for the Maryland-National Capital Park and Planning Commission was adopted by CB-18-2009 and amended by CR-25-2010; and

WHEREAS, the Prince George's County Planning Board, by letter dated May 13, 2010, requested that certain portions of this budget be amended; and

WHEREAS, under the provisions of Article 28, Annotated Code of Maryland, Section 2-118(a)(6), the budget may be amended by resolution by the respective County Council on their initiative; and

WHEREAS, the Merit System Board's total budget appropriation of \$56,300 per County, provided through the Administration Fund Tax, is below estimated expenditures for FY10; and

WHEREAS, the Merit System Board addressed a backlog of cases from FY09 and continues to hear a number of appeals cases originating in the current fiscal year; and

WHEREAS, due to the higher than expected expenses for many complex cases, the Merit System Board requires a FY10 budget increase in the amount of \$16,500 in each County; and

WHEREAS, the source of funds for this increase would be transfers from each of the Central Administrative Services (CAS) Departments of Human Resources and Management, Finance and Legal, by reducing each of these departments' FY10 budget appropriation level by \$5,500 in Prince George's County; and

WHEREAS, there is also a need to reallocate \$462,000 of funding from the Recreation Fund to the Park Fund, including \$440,000 of project charges for the Community College to better match estimated spending of the Community College on different activities in FY2011 and \$22,000 for associated impact on reserves; and

WHEREAS, the impact on tax revenues and expenditures overall would be \$0 and the impact on total project charges for the Community College would be \$0;

NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's County, Maryland, that the following adjustments, for the purposes set forth above, to the Commission's Approved Fiscal Year 2010 Budget as approved in CB-18-2009 and amended in CR-25-2010 be made to the Administration Fund, the Park Fund, and the Recreation Fund as follows:
