A RESOLUTION concerning

Maryland-National Capital Park and Planning Commission

Capital Improvement Program Fiscal Year 1997-2002

For the purpose of amending the Prince George's County portion of the Maryland-National Capital Park and Planning Commission's Capital Improvement Program for Fiscal Year 1997-2002 and the Fiscal Year 1997 Capital Budget, to increase appropriation authority for the Prince George's Sports and Learning Complex.

WHEREAS, Article 28, Section 2-118, of the Annotated Code of Maryland provides for the amendment of the Capital Improvement Program of the Maryland-National Capital Park and Planning Commission by the County Governing Body on its own initiative or at the request of the Commission and after public hearing upon reasonable notice to the public; and

WHEREAS, the Maryland-National Capital Park and Planning Commission has requested an amendment to the Prince George's County portion of the Maryland-National Capital Park and Planning Commission's Capital Improvement Program for FY 1997-2002, as adopted by CB-21-1996, to increase appropriation authority for the Prince George's Sports and Learning Complex project (CIP ID #ECO70984) from a total project appropriation of \$37,391,000 to \$51,891,000;

WHEREAS, the Maryland-National Capital Park and Planning Commission has requested an amendment to the FY 1997 Capital Budget increasing the appropriation authority from \$12,391,000 to \$31,391,000, for the Prince George's Sports and Learning Complex (CIP ID #ECO70984);

WHEREAS, the Maryland-National Capital Park and Planning Commission has identified the sources of funding for the amendment; and

WHEREAS, the Prince George's Sports and Learning Complex was approved in the FY 1997 Capital Improvement Program as Prince George's Sports Complex at Landover (as adopted by CB-21-1996); and

WHEREAS, FY 1997 funding for this project is from a State Bond Bill in the amount of \$3 Million, a foundation grant via a developer contribution in the amount of \$3 Million, and County/Commission funds of \$4.1 Million from the sale of property, and \$21.3 Million from Commission bond sales and operating transfers; and

WHEREAS, the County Executive has recommended to the County Council such amendment; and

WHEREAS, the County Council has conducted a public hearing on the proposed amendment having given reasonable notice thereof.

NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's County, Maryland, that the Fiscal year 1997-2002 Maryland-National Capital Park and Planning Commission Capital Improvement Program is revised to amend the Prince George's Sports and Learning Complex project (ECO70984) as shown in Attachment "A" attached hereto and made a part thereof.

BE IT FURTHER RESOLVED that the Fiscal Year 1996-1997 Capital Budget of the Maryland-National Capital Park and Planning Commission, as adopted by CB-21-1996, Appendix B, is hereby amended to increase the amount in the Commission's Capital Budget to \$31,391,000 for the Prince George's Sports and Learning Complex project (ECO70984), as shown in Attachment "A" attached hereto and made a part thereof.

BE IT FURTHER RESOLVED that Fiscal Year 1997 funds for this project shall be derived from the State (\$3 Million), local funds from the sale of the property (\$4.1 Million), Commission bond sales and operating transfers (\$21.3 Million), and a developer contribution (\$3 Million).
