WHEREAS	S, Section 15-103 of the Land Use Article of the Annotated Code of Maryland
further requires t	hat the appointment resolution for each appointment shall describe the resulting
geographic distri	bution and provide appropriate explanations; and
WHEREAS	S, the County Executive has duly nominated William M. Doerner, a resident of
Hyattsville, to re	place John P. Shoaff, a resident of University Park, who moved his primary
residence out of	Prince George's County; and
WHEREAS	S, the County executive has duly nominated A. Shuanise Washington, a resident
of Mitchellville	for reappointment as a member of the Commission; and
WHEREAS	S, a public hearing on the nomination and confirmation of William M. Doerner
and A. Shuanise	Washington has been held; and
WHEREAS	S, the remaining members of the Commission from Prince George's County are

residents of Bowie, Hyattsville, Fort Washington, and Temple Hills respectively.

1	NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's
2	County, Maryland, that, with the appointment of William M. Doerner and A. Shuanise
3	Washington to the Maryland-National Capital Park and Planning Commission, there continues to
4	be reasonable geographic distribution with respect to the places of residence of the members of
5	the Commission from Prince George's County.
6	BE IT FURTHER RESOLVED that William M. Doerner is hereby confirmed as a member
7	of the Maryland-National Capital Park and Planning Commission with a term expiring June 15,
8	2018.
9	BE IT FURTHER RESOLVED that A. Shuanise Washington is hereby confirmed as a
10	member of the Maryland-National Capital Park and Planning Commission with a term expiring
11	June 15, 2020.
