1. **CB-4-2010**- (County Executive) An Act amending the Prince George's County Classification Plan in order to create a generic Public Safety Recruit class of work.

2. **CR-9-2010**- (County Executive) A Resolution endorsing a loan not to exceed \$80,000 to hhgregg, Inc. ("hhgregg") from the Maryland Economic Development Assistance Fund ("MEDAF") and authorizing a loan by the County to hhgregg not to exceed \$50,000 for eligible project costs associated with leasing a facility in the County and capital expenditures.

3. ***CR*-10-2010**- (County Executive) A Resolution endorsing a loan not to exceed \$100,000 to Limbach Company LLC ("Limbach") from the Maryland Economic Development Assistance Fund ("MEDAF") and authorizing a loan by the County to Limbach not to exceed \$20,000 for eligible project costs associated with leasing a facility in the County and capital expenditures.
