**RESOLUTION**

1 A RESOLUTION concerning  
2 Maryland-National Capital Park and Planning Commission  
3 For the purpose of approving certain transfers of appropriations within the Approved FY 2023–  
4 24 Park Fund and the Recreational Fund of the Approved Fiscal Year 2023–24 Maryland-  
5 National Capital Park and Planning Commission.

6 WHEREAS, the Annual Budget and Appropriation Ordinance for the Prince George’s  
7 County portion of the Maryland-National Capital Park and Planning Commission for Fiscal Year  
8 2023–24 was adopted on May 25, 2023 by approval of CB-62-2023; and

9 WHEREAS, under the provisions of Title 18, Land Use Article, Annotated Code of  
10 Maryland, the Commission budget may be amended by resolution of the respective County  
11 Councils on their initiative after public hearing upon reasonable notice to the public; and

12 WHEREAS, there is a need to fund the following program: Joan’s House, Inc.; and  
13 WHEREAS, in order to identify additional funding for that named program, there is a need  
14 to decrease funding from the approved Park Fund for The City of Forest Heights  
15 (Beautification); and

16 WHEREAS, Section 18-108 of the Land Use Article provides a process by which approved  
17 Commission budgets may be amended by resolution of the County Council after public hearing  
18 upon reasonable notice to the public.

19 NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's  
20 County, Maryland, that the following adjustments to the approved Fiscal Year 2023–24  
21 Maryland-National Capital Park and Planning Commission Operating Budget Park Fund and the  
22 approved Fiscal Year 2023–24 Maryland-National Capital Park and Planning Commission  
23 Operating Budget Recreation Fund, as approved in CB-062-2023, are hereby made for the

purposes set forth above:
