### <sup>4</sup>Analysis of the full personnel cost of the legislation

Upon analysis of the collective bargaining agreement for the Prince George's Police Officials, it has been found that the realized fiscal impact of cost-of-living adjustments (COLAs), merit payments and clothing allowance to be paid out in Fiscal Years 2025 and 2026 is approximately \$1,195,288, with an annual impact of \$963,816 each year thereafter. The current number of employees covered by the agreement is 65.

\*Note: This Council Resolution covers the collective bargaining agreement for FY25 and FY26 only. Negotiations for FY27 and FY28 will begin at the end of 2025 so there are no additional compensation and fringe adjustments at this point.
