**RESOLUTION**

1 A RESOLUTION concerning

2           The Approval of an Application to Preserve Property pursuant to the  
3           Maryland Agricultural Land Preservation Foundation Program

4 For the purpose of recommending that the Maryland Agricultural Land Preservation Foundation  
5 approves the application of the Estate of Francis Moore James Donohue to permanently preserve  
6 their property.

7       WHEREAS, the application, dated August 23, 2010, by the Estate of Francis Moore James  
8 Donohue requested the permanent preservation of approximately 147.94 acres (Tax Map  
9 160/Grid E2/Parcel 46/Tax Account 05-0309443) located at 16501 Old Marshall Hall Road in  
10 Accokeek, Prince George’s County, Maryland, as generally shown on the attached location  
11 maps; and

12       WHEREAS, the application was referred to the Prince George’s County Agricultural  
13 Preservation Advisory Board and the Prince George’s County Planning Board for review and  
14 recommendation;

15       WHEREAS, the Prince George’s County Agricultural Preservation Advisory Board found  
16 that the Estate of Francis Moore James Donohue property met the qualifying criteria for  
17 productivity, size and location as set by the Maryland Agricultural Land Preservation  
18 Foundation, and recommended approval of the application on September 30, 2010; and

19       WHEREAS, the Prince George’s County Planning Board found that the application to  
20 permanently preserve this property is compatible with existing and approved county plans and  
21 recommended approval of the application on November 18, 2010; and

22       NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's

1 County, Maryland, that Tax Map 160/Grid E2/Parcel 46/Tax Account 05-0309443, as described  
2 in the application filed by the Estate of Francis Moore James Donohue is recommended to the  
3 Maryland Agricultural Land Preservation Foundation for approval.

4 BE IT FURTHER RESOLVED that this resolution, copies of the application, maps and  
5 copies of the letters from the Agricultural Preservation Advisory Board and the Prince George's  
6 County Planning Board, be forwarded by the Clerk of the Council to the County Executive for  
7 his consideration and, upon his approval, transmitted to the Maryland Agricultural Land  
8 Preservation Foundation for appropriate action.
