**BACKGROUND INFORMATION/FISCAL IMPACT:**

This Bill is being submitted pursuant to Section 903 of Article IX of the Charter and Section 16-125 (a) of Subtitle 16 of the County Code. As enacted by CB-31-2020, the Public Safety Audio and Video Records Technician class of work was added to salary schedules "G", "H", "P" and "Z". It was recently discovered that there was an error made that established the class at grade 23 instead of grade 21. This legislation would correct the error to the impacted schedules, add the class of work to the "Q" salary schedule at grade 21; as well as add a Public Safety Emergency Call Taker III class of work to the "Z" salary schedule at grade 20.

The fiscal impact will be provided by the Office of Management and Budget.
