BILL

AN ACT concerning

Public Spas

For the purpose of amending the County Code to modify public spa licensing fee provisions

BY repealing and reenacting with amendments:

SUBTITLE 5. BUSINESSES AND LICENSES.

Section 5-276(c),

The Prince George's County Code

(1995 Edition).

SECTION 1. BE IT ENACTED by the County Council of Prince George's County, Maryland, that Section 5-276(c) of the Prince George's County Code be and the same is hereby repealed and reenacted with the following amendments:

SUBTITLE 5. BUSINESSES AND LICENSES.

DIVISION 22. PUBLIC SPAS.

Subdivision 2. Licenses.

Sec. 5-276. Public spa license required.

(a) It shall be unlawful for any person to operate or permit to be operated within the County a public spa unless an application therefor has been approved and a license issued by the Health Department in compliance with this Division.

(b) Application for a public spa license shall be made upon a form prescribed by the Health Officer, who shall ensure that requisite approvals of other State and County

departments have been obtained before issuing such license. Either the owner, lessor, or property management company of the public spa shall be the responsible party and shall sign as the licensee.

(c) Each application for a public spa license shall be accompanied by a fee[of Two Hundred Fifty Dollars (\$250.00),] to be proposed and recommended by the County Executive and adopted by resolution of the County Council. No [no] part of [which] the adopted fee shall be refundable. Except, however, that no fee shall be required for public spas which are located on the same premises with swimming pools currently licensed by the Health Department in accordance with Division 17 of this Subtitle. [A duplicate license will be issued, on request, at a charge of Fifteen Dollars (\$15.00).]

(d) Public spa licenses issued pursuant to this Subsection shall be issued for a period not to exceed one year, and shall terminate on December 31 of each year.

SECTION 2. BE IT FURTHER ENACTED that this Act shall take effect forty-five (45) calendar days after it becomes law.
