BACKGROUND INFORMATION/FISCAL IMPACT:

This bill will amend the Commercial Use Tables of the Zoning Ordinance to provide for "Eating or drinking establishment of any type, including music and patron dancing past the hours of 12:00 A.M., excluding adult entertainment," as a permitted use in the C-S-C (Commercial Shopping Center) Zone, provided the use meets certain minimum square footage, permit, and liquor license requirements.
