(234.1) Tattoo Parlor: An establishment wherein designs, letters, figures, body piercing or other marks are placed upon the skin of any person, using ink or other substances that result in the permanent coloration or piercing of the skin by means of use of needles or other instruments designed to contact or puncture the skin.

3 2012, may continue operations and shall not be deemed nonconforming.

4 SECTION 3. BE IT FURTHER ENACTED that this Ordinance shall take effect on the date of  
5 its adoption.
