BACKGROUND INFORMATION/FISCAL IMPACT:

Currently the budget and personnel functions for the HAPGC are part of Department of Housing and Community Development ("DHCD"). To help make HAPGC more efficient and to mirror actual operations in that HAPGC is run by an Executive Director with little operational, daily oversight from the DCHD Director, these legislative changes are needed.
