**RESOLUTION**

1 A RESOLUTION concerning

2 The National Infrastructure Bank Act of 2025

3 For the purpose of expressing The County Council’s support for federal legislation cited as the  
4 “National Infrastructure Bank Act of 2025” (H. R. 5356, 119<sup>th</sup> Cong. (2025).

5 WHEREAS, the federal legislation currently being proposed is cited as the “National  
6 Infrastructure Bank Act of 2025” (H. R. 5356, 119<sup>th</sup> Cong. (2025) (The “Act”); and

7 WHEREAS, The Act would establish a National Infrastructure Bank as a financing tool to  
8 support critical infrastructure investment, economic development, job creation, and equitable  
9 growth benefiting Prince George’s County; and

10 WHEREAS, Prince George’s County faces increasing infrastructure demands across  
11 transportation, water and sewer systems, public facilities, housing, broadband, energy, and  
12 climate resilience as aging assets, population growth, and climate-related risks place continued  
13 pressure on long-term capital investment; and

14 WHEREAS, traditional funding tools such as bond financing and limited grant programs  
15 often restrict the County’s ability to deliver projects efficiently and equitably, leading to delays,  
16 higher costs, and disparate investment; and

17 WHEREAS, an infrastructure bank financing approach as proposed in the Act could  
18 provide a flexible, long-term funding mechanism to strengthen capital planning, expand  
19 financing capacity, and support coordinated, equitable infrastructure investment across urban,  
20 suburban, and underserved communities; and

21 WHEREAS, exploring an infrastructure bank financing model presents an opportunity for  
22 Prince George’s County to strengthen its long-term infrastructure planning, improve project

1 delivery, and promote more equitable investment across communities; and

2 WHEREAS, further evaluation of this financing approach would help determine its  
3 potential to complement existing funding tools while maintaining fiscal responsibility and public  
4 oversight.

5 NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's  
6 County, Maryland, that the County Council enthusiastically supports enactment of the “National  
7 Infrastructure Bank Act of 2025” (H. R. 5356, 119<sup>th</sup> Cong. (2025) (The “Act”).

8 BE IT FURTHER RESOLVED that the County Council looks forward to Prince George’s  
9 County utilizing the financing proposed in the Act to provide a flexible, long-term funding  
10 mechanism to strengthen capital planning, expand financing capacity, and support coordinated,  
11 equitable infrastructure investment across urban, suburban, and underserved communities.
