##### PUBLIC SAFETY AND FISCAL MANAGEMENT

Committee vote: Favorable, 3-0, (In favor: Councilmembers Peters, Dean and Knotts.)

This resolution will amend the Salary Plan in Salary Schedules S, M, R and Y for employees in the International Association of Fire Fighters, (IAFF), AFL-CIO, Local 1619 (Fire Fighters, Paramedics, Emergency Response Technicians and Fire Fighter/Medics) and will reflect modifications of the two year Agreement. (July 1, 2005 - June 20, 2007).

**BACKGROUND INFORMATION/FISCAL IMPACT:**

(Includes reason for proposal, as well as any unique statutory requirements)

This is companion legislation to the bill to approve the collective bargaining agreement between Prince George's County, Maryland and the International Association of Fire Fighters, AFL-CIO, Local 1619 (Fire Fighters, Paramedics, Emergency Response Technicians and Fire Fighter/Medics) for Fiscal Years 2006 and 2007. This resolution reflects modifications of the agreement. Salary Schedules S, M and R cover Fiscal Year 2006 and a merger of these three Salary Schedules will result in the establishment of Salary Schedule Y which will be effective Fiscal Year 2007. The estimated fiscal impact will be provided by the Office of Management and Budget.

The proposed salary plan amendments were submitted to the County Council by the County Executive on June 6, 2006. Pursuant to Section 903 of the Charter, if the Council fails to take final action on the proposed salary plan before August 5, 2006, the salary plan shall stand approved.
