BACKGROUND INFORMATION/FISCAL IMPACT:

This Resolution will approve a proposed First Amendment to an Original Lease Agreement that previously approved by the Council and executive by and between the Maryland-National Capital Park and Planning Commission and ATP Realty and Equipment Company LLC, now operated by its successor in interest STC Three LLC, also known as Crown Castle USA Inc., as to certain property in the County for telecommunications utility services, consistent with park purposes.
