It is my pleasure to submit to you and the County Council the appointments of Mr. Ishaq H. Majeed, Mr. Manuel Pascual, Mr. Frederick J. Rogers, Mr. Anthony Tilghman, and Mr. Robert Windley to the Prince George's County Commission on Fathers, Men and Boys. The Commission on Fathers, Men and Boys was established to advise the County Executive, the County Council, County agencies, and the public on issues and needs of fathers, men, and boys in Prince George's County.

Mr. Ishaq H. Majeed, a resident of Cheverly, is an Information Technology (IT) professional with over twenty (20) years' experience. He started Kubra Cybersecurity to expand IT and cybersecurity opportunities for minorities. Active in the community, he volunteers with non-profit organizations and has served on organizing committees for international conferences in Prince George's County and New York City. Mr. Majeed is a graduate of Morehouse College with a Bachelor of Science degree in Mathematics and a graduate of The Chicago Theological Seminary in Partnership with the Bayan Islamic Graduate School where he received his Master of Arts degree in Islamic Studies.

Mr. Manuel Pascual, a resident of Oxon Hill, is an experienced and driven professional in the areas of local, state, and federal rules and regulations with a focus on property management. He had previously served as Regional Manager for the United Colors of Benneton. Mr. Pascual volunteered with Casa de Maryland to ensure the Latino community had access to their voting rights. He received his Bachelor of Law/Juris Doctor degree from the Universidad Bicentenaria de Aragua in his native country, Venezuela; his Master of Law from the Caribbean International University; and after immigrating to the United States, he obtained a Bachelor of Science degree in Business Administration from Atlantis University.

Mr. Frederick J. Rogers, a resident of Beltsville, is a public servant with the United State Department of Justice where he manages a grant portfolio more than \$540,000,000 for the United States and territories. He has served in numerous roles while employed with the Government of the District of Columbia including, but not limited to Program Manager, EEOC Counselor. Program Grant Manager, Education Administrator/Director, and Juvenile Program Manager. He also served

as Dean of Students and Disciplinarian Residential Dean in the education sector. Mr. Rogers received his undergraduate degree from Howard University and a graduate degree from Temple University.

Mr. Anthony B. Tilghman, a resident of District Heights, is an award-winning photographer, mentor, and published author. He has served as a featured photographer for events including Presidential Inaugurations, Congressional Black Caucus, the Grammys, and the Academy Awards. Additionally, he is a Multimedia Educator with Montgomery Community Media and serves as Director of Constituent Services for Maryland Delegate Nick Charles. He previously served as a Program Facility Manager Aide with the Maryland-National Capital Park and Planning Commission (M-NCPPC). Mr. Tilghman received his undergraduate degree from Howard University.

Mr. Robert F. Windley, a resident of Laurel, is the Founder and CEO of Skyline Media Strategies, LLC where he manages social media accounts for nonprofits and businesses and creates digital advertisements and email marketing for clients. He is also a partner with Windley Management Group, LLC. In that role, he partners with HUBZone, Minority Owned, 8(a), SDVOB, and other types of companies for business

development, branding, and consulting. He previously served as Special Assistant to the Secretary – Maryland Department of Health and Director of Constituent Services – Office of Former Governor Larry Hogan.
