**BACKGROUND INFORMATION/FISCAL IMPACT:**

This Resolution will amend the Prince George’s County Fiscal Year (“FY”) 2022 Annual Action Plan for Housing and Community Development by adding new CDBG activities, eligible activities not originally funded or described in the FY 2022 Annual Action Plan.

Additionally, this Resolution will amend the FY 2022 Annual Action Plan by reprogramming and reallocating three hundred sixty-nine thousand, eight hundred and eighty-six dollars (\$369,886) in Community Development Block Grant (“CDBG”) Program funds from the FY 2015, FY 2016, FY 2017 and FY 2018 Annual Action Plans to support the new activities.
