**BACKGROUND INFORMATION/FISCAL IMPACT:**

This Resolution will amend the Prince George’s County Fiscal Year (“FY”) 2021 Annual Action Plan for Housing and Community Development by adding the Pathway to Purchase Program (formerly known as *My HOME* Program), an eligible activity not originally funded or described in the FY 2021 Annual Action Plan.

Additionally, this Resolution will amend the FY 2021 Annual Action Plan by reprogramming and reallocating seven hundred sixty-one thousand, five hundred fifty-three dollars (\$761,553) in HOME Investment Partnerships (“HOME”) Program funds from the FY 2019 Annual Action Plan to support the project.
