BACKGROUND INFORMATION/FISCAL IMPACT: (Includes reason for proposal, as well as any unique statutory requirements) This resolution will provide for supplementary appropriations for grant programs in Fiscal Year 2011. The adjustments to appropriations total \$1,207,155 and will support program efforts in the Police Department, Office of Homeland Security, Department of Social Services, Health Department and Department of Family Services
There will not be a negative fiscal impact on the County as a result of adopting CR-73-2011.
The grant appropriations reflect \$607,235 in direct Federal allocations, \$396,910 in State allocations and \$203,010 in other funding source. There are no County funds appropriated.
The resolution was amended to correct a technical error on page 2 to change the headings "2012 Approve Budget" and "2012 Revised Budget" to "2011 Approved Budget" and "2011 Revised Budget".
