BILL

1 AN ACT concerning

2 The Classification Plan for Prince George's County

3 For the purpose of adding new classes of work to the V Salary Schedule represented by the
 4 Service Employees International Union (SEIU) Local 400PG. This is being done in accordance
 5 with the collective bargaining agreement made by and between Prince George's County,
 6 Maryland and SEIU Local 400PG for Fiscal Years 2006 and 2007.

7 WHEREAS, the County Executive, pursuant to Section 903 of the Prince George's County
 8 Charter and Section 16-125(a) of Subtitle 16 of the Prince George's County Code, has, in order
 9 to provide better governmental services, recommended to the County Council amendments to the
 10 Classification Plan for Prince George' County with respect to certain classes of work described
 11 within Section 1 of this Bill, now, therefore,

12 SECTION 1. BE IT ENACTED by the County Council of Prince George's County,
 13 Maryland, that the Classification Plan of the Prince George's County Code be and the same is
 14 hereby amended as follows:

21 0142V Administrative Aide II, V-15

[(\$30,371 - \$53,534)] \$28,908 - \$50,955

0143V Administrative Aide III, V-17

[(\$33,483 - \$59,022)] \$31,870 - \$56,178

SECTION 2. BE IT FURTHER ENACTED that this Act shall take effect forty-five (45) calendar days after it becomes law and shall be retroactively effective to July 1, 2005.
