AN ACT concerning

Collective Barganing Agreement International Assocation of Fire Fighters,

Local 1619, AFL-CIO (Uniformed Civilian Unit)

FOR the purpose of approving the labor agreement by and between Prince George's County and International Association of Fire Fighters, Local 1619, AFL-CIO, to provide for wage increases and certain other terms and conditions of employment for personnel classifications certified by the Prince George's County Public Employee Relations Board.

BY repealing and reenacting with amendments:

SUBTITLE 16. PERSONNEL.

Section 16-233(f)(16),

The Prince George's County Code (1987 Edition, 1989 Supplement).

SECTION 1. BE IT ENACTED by the County Council of Prince George's County, Maryland, that Section 16-233(f)(16) of the Prince

George's County Code be and the same is hereby repealed and reenacted with the following amendments:

Sec. 16-233. General.

- (f) The following collective bargaining agreements are hereby adopted and approved:
- (16) Declaration of Approval International Association of Fire Fighters, Local 1619 (Uniformed Civilian Unit).

The County Council of Prince George's County, Maryland, having fully considered the labor agreement concluded between Prince George's County and International Association of Fire Fighters, Local 1619 on [December 15, 1988] May 30, 1990, hereby approves said agreement for employees in the uniformed civilian bargaining unit in the Fire Department in accordance with the provisions of Section 13A-109 of the Prince George's County Code.

SECTION 2. BE IT FURTHER ENACTED that this Act shall take effect forty-five (45) calendar days after the date it becomes law and the provisions of the labor agreement shall be retroactively effective to July 1, 1989.
