CR-46-2006 – A RESOLUTION CONCERNING COMPENSATION AND BENEFITS, INTERNATIONAL ASSOCIATION OF FIRE FIGHTERS, LOCAL 1619, AFL-CIO (CIVILIANS) SALARY SCHEDULE "H" for the purpose of amending the Salary Plan of the County to reflect the terms of the labor agreement by and between Prince George's County and the International Association of Fire Fighters, Local 1619, AFL-CIO (Civilians).

Council Resolution 46 introduced at the request of the County Executive and referred to Public Safety and Fiscal Management (PSFM) Committee. Council Resolution 46 amends Salary Schedule H for the International Association of Fire Fighters, Local 1619, AFL-CIO (Civilians), effective July 1, 2005 through June 30, 2007. Council Resolution 46 was introduced by Council Members Dernoga, Dean, Exum, Peters, Knotts, Harrington, Campos and Bland.

<u>CR-49-2006 – A RESOLUTION CONCERNING COMPENSATION AND BENEFITS</u>
<u>GENERAL SCHEDULE EMPLOYEES – SALARY SCHEDULE G</u> for the purpose of amending the Salary Plan of the County to reflect pay rates and other modified benefits for General Schedule employees. - <u>INTRODUCED</u>

Council Resolution 49 was introduced at the request of the County Executive and referred to Public Safety and Fiscal Management (PSFM) Committee. Council Resolution 49 amends Salary Schedule G to reflect an adjustment of the minimum wage rate in accordance with a State mandate effective February 16, 2006, a cost of living increase and other modified benefits for General Schedule employees. Council Resolution 49 was introduced by Council Members Dernoga, Peters, Knotts, Dean, Exum, Harrington, Campos and Bland.

CR-50-2006 – A RESOLUTION CONCERNING ECONOMIC DEVELOPMENT **REVENUE BONDS** for the purpose of issuing, pursuant to and in accordance with the Maryland Economic Development Revenue Bond Act, of economic development revenue bonds in an aggregate principal amount not to exceed Sixty-five Million Dollars (\$65,000,000), and to loan the proceeds from the sale of such bonds to Collington Episcopal Life Care Community, Inc., a not-for-profit corporation organized under the laws of the State of Maryland, to be used for the purpose of financing or refinancing the costs of certain facilities, within the meaning of such Act, located in Prince George's County, Maryland to be used by such corporation for its tax-exempt purposes of providing a continuing care retirement community for senior citizens, authorizing the County Executive to specify, prescribe, determine, provide for, approve, execute and deliver any and all matters, details, forms, documents or procedures necessary or appropriate to effectuate the authorization, sale security, issuance, delivery and payment of and for such bonds and lending the proceeds thereof; reserving certain rights in the County; providing for the effective date of this Resolution; providing for the termination of this Resolution; and generally providing for and determining various matters in connection with such bonds and the lending of the proceeds thereof.

- INTRODUCED

Council Resolution 50 was introduced at the request of the County Executive and referred to Public Safety and Fiscal Management (PSFM) Committee. Council Resolution 50 concerns Economic Development Revenue Bonds for the purpose of authorizing the issuance of revenue

bonds pursuant to the Maryland Economic Development Revenue Bond Act in an aggregate amount not to exceed Sixty-five Million Dollars (\$65,000,000) and to loan the bond proceeds to Collington Episcopal Life Care Community, Inc., a not-for-profit Maryland corporation for the purpose of refinancing the costs of providing a continuing care retirement community for senior citizens. Council Resolution 50 was introduced by Council Members Peters and Campos.

CB-31-2006 – AN ORDINANCE CONCERNING USE AND OCCUPANCY PERMITS

for the purpose of authorizing all immediate reasonable and necessary action to cease and desist the operation of any activity requiring a use and occupancy permit when a use and occupancy permit has not been issued; authorizing all immediate reasonable and necessary action to cease and desist the operation of any activity requiring a use and occupancy permit when a use and occupancy permit has been issued and is not in compliance with the provisions of the Zoning Ordinance; authorizing all immediate reasonable and necessary action to cease and desist the operation of any activity requiring a use and occupancy permit when the activity is found to present an imminent danger and threat to the health, safety, and welfare of the public by not doing so, that there are no other mitigating circumstances to be taken to resolve the imminent danger and threat to the health, safety, and welfare of the public, and that there are no other reasonable means of preventing further danger and threat to the health, safety, and welfare of the public resulting from the continuation of the activity; authorizing all immediate reasonable and necessary action to cease and desist the operation of any activity requiring a temporary use and occupancy permit when a temporary use and occupancy permit has not been issued; authorizing all immediate reasonable and necessary action to cease and desist the operation of any activity requiring a temporary use and occupancy permit when a temporary use and occupancy permit has been issued and is not in compliance with the provisions of the Zoning Ordinance; authorizing all immediate reasonable and necessary action to cease and desist the operation of any activity requiring a temporary use and occupancy permit when the activity is found to present an imminent danger and threat to the health, safety, and welfare of the public by not doing so, that there are no other mitigating circumstances to be taken to resolve the imminent danger and threat to the health, safety, and welfare of the public, and that there are no other reasonable means of preventing further danger and threat to the health, safety, and welfare of the public resulting from the continuation of the activity; authorizing all immediate reasonable and necessary action to implement this Act for the health, safety and welfare of the public; providing for the designation of certain public officials to enforce this Act; providing for enforcement procedures to implement this Act; providing for establishing policies, rules, and procedures to implement this Act; providing for a hearing before the Zoning Hearing Examiner from a violation of this Act; providing for an appeal from the decision of the Zoning Hearing Examiner to the Circuit Court of Maryland; providing for the computation of time pursuant to this Act; and generally relating to use and occupancy permits.
