1. **CONSENT AGENDA -- CB-40, 41, 42 & CR-34 ADDED (SEE PAGE 7); ADOPTED AND ALL ACTIONS APPROVED**

All items listed under the consent agenda have been distributed to each member of the Council for review, are considered to be routine and will be acted upon by motion in the form listed. There will be no separate discussion of these items. If discussion is desired, that item will be removed from the consent agenda and considered separately.

(a) **First Reading of Bills (Presentation)**

CB-37-2003 – AN ORDINANCE CONCERNING I-2 ZONE for the purpose of amending the requirements for churches in the I-2 Zone. - **PRESENTED**

Council Bill 37 was presented by Council Member Harrington and referred to the Planning, Zoning and Economic Development Committee.

CB-38-2003 - AN ACT CONCERNING SUPPLEMENTARY APPROPRIATIONS AND INTERDEPARTMENTAL TRANSFER OF APPROPRIATIONS for the purpose of appropriating to the General Fund revenue in excess of budget estimates, to provide funds for costs that were not anticipated in the approved FY 2002-2003 budget for various agencies and to transfer surplus appropriations reflecting savings from various County Departments. - **PRESENTED**

Council Bill 38 was presented by the Chairman at the request of the County Executive and referred to the Public Safety and Fiscal Management Committee.

CB-40-2003 - AN ACT CONCERNING SUPPLEMENTARY APPROPRIATIONS for the purpose of appropriating additional revenue from prior year available and uncommitted fund balance to the Drug Enforcement and Education Special Revenue Fund, to provide funds for costs that were not anticipated in the Approved Fiscal Year 2002-2003 Budget for the Drug Enforcement and Education Special Revenue Fund. - **PRESENTED**

Council Bill 40 was presented by the Chairman at the request of the County Executive and referred to the Public Safety and Fiscal Management Committee.

CB-41-2003 (EMERGENCY BILL) – AN EMERGENCY ACT CONCERNING BUILDING CODE for the purpose of amending the Building Code to include a provision authorizing the Building Code Official to abate unsafe conditions. - **PRESENTED**

After reading the above citation for Council Bill 41, Chairman Shapiro announced that "a public emergency exists affecting the public health, safety, or welfare; said emergency being the need to amend the County Building Code to authorize the Building Code Official to cause the demolition of structures deemed to be unsafe, posing an imminent danger or threat to the public safety, health, and human life." Council Bill 41 was presented by Chairman Shapiro at the request of the County Executive and referred to the Transportation, Housing and the Environment Committee.

CONSENT AGENDA – (CONTINUED)

CB-42-2003 – AN ORDINANCE CONCERNING M-U-I ZONE for the purpose of authorizing the District Council to approve the M-U-I Zone (Mixed Use, Infill) on property owned by a municipality, modifying the M-U-I Zone application and approval requirements, and making related amendments to the Zoning Ordinance. - **PRESENTED**

Council Bill 42 was presented by Council Member Harrington and referred to the Planning, Zoning and Economic Development Committee.

(b) **Introduction of Resolutions**

CR-34-2003 – A RESOLUTION CONCERNING THE 2001 WATER AND SEWERAGE PLAN (APRIL 2003 CYCLE OF AMENDMENTS) for the purpose of changing the water and sewer category designations of properties within the 2001 Water and Sewer Plan. - **INTRODUCED**

Council Resolution 34, as proposed by Chairman Shapiro at the request of the County Executive, amends the 2001 Water and Sewerage Plan with category change requests to properties within the Parkway, Western Branch, Piscataway and Mattawoman sewersheds. Council Resolution 34 was introduced by Council Members Shapiro, Dean and Exum and referred to the Transportation, Housing and the Environment Committee. Chairman Shapiro announced that the public hearing for Council Resolution 34 would occur Tuesday, July 22, 2003 at 10:00 a.m.

A letter was proposed to be sent to Mr. Neil J. Pedersen regarding final project planning for the MD 3 Transportation Corridor Study. Council Member Dean, as Chairman of the Transportation, Housing and the Environment Committee provided a verbal report of the actions and recommendations of the committee. The letter was favorably reported out of THE on 6/12/2003. Council Member Dean then moved to authorize the Chairman's signature; seconded by Council Member Dernoga. The motion carried 9-0.

- (b) Proposed letter to Mr. Neil J. Pedersen, Administrator, Maryland Department of Transportation, State Highway Administration, regarding full-time operation of the I-95/Arena Drive Interchange. - **CHAIRMAN AUTHORIZED TO SIGN**

A letter was proposed to be sent to Mr. Neil J. Pedersen regarding the full-time operation of the I-95 Arena Drive Interchange. Council Member Dean, as Chairman of the Transportation, Housing and the Environment Committee provided a verbal report of the actions and recommendations of the committee. The letter was favorably reported out of THE on 6/12/2003. Council Member Dean then moved to authorize the Chairman's signature; seconded by Council Member Knotts. The motion carried 9-0.

4. **SECOND READING OF BILLS (INTRODUCTION)**

CB-19-2003 (DR-2) – AN ORDINANCE CONCERNING PEOPLE'S ZONING COUNSEL for the purpose of amending the powers and duties of the People's Zoning Counsel and amending the qualifications and term of office. - **INTRODUCED**

Council Member Harrington, as Chairman of the Planning, Zoning and Economic Development Committee, provided a verbal report of the actions and recommendation of the committee. Council Bill 19, which amends the powers, duties, qualifications and term of office of the People's Zoning Counsel, was favorably reported out of PZED on 6/4/2003 with amendments. Council Bill 19, Draft 2 was introduced by Council Members Harrington, Dernoga, Knotts, Peters, Shapiro and Dean.

SECOND READING OF BILLS (INTRODUCTION) – (CONTINUED)

CB-43-2003 (EMERGENCY BILL) - AN EMERGENCY ACT CONCERNING BUILDING PERMITS for the purpose of limiting the number of building permits that may be issued in the Rural Tier, and of providing for certain exceptions. - **INTRODUCED**

After reading the above citation for Council Bill 43, Chairman Shapiro announced that "a public emergency exists affecting the public health, safety, and welfare; said emergency being the need to protect the natural and built environment of the Rural Tier by limiting the construction of dwellings in the Rural Tier in accordance with the Approved General Plan of Prince George's County." Council Member Hendershot raised a point of order regarding the provided emergency clause and requested that additional information be provided to Council as justification. Council Bill 43 was introduced by Council Members Harrington, Dernoga, Shapiro, Dean and Peters and referred to the Planning, Zoning and Economic Development Committee.

CB-30-2003 (SUBDIVISION BILL) - AN ACT CONCERNING ADEQUATE SCHOOL FACILITIES for the purpose of eliminating the provisions for payment of a per-dwelling unit fee in conjunction with a school facilities adequacy test. - **AMENDED; DR-2 ENACTED; RECONSIDERED; PUBLIC HEARING HELD; AMENDED; DR-2 ENACTED**

Council Member Harrington, as Chairman of the Planning, Zoning and Economic Development Committee, provided a verbal report of the actions and recommendation of the committee. Council Bill 30 was introduced by Council Members Harrington, Shapiro, Dean, and Knotts on 5/6/2003 and favorably reported out of PZED on 6/11/2003 with recommended amendments. Council Member Hendershot moved amendment number one; seconded by Council Member Harrington. The motion carried by voice vote. Council Member Peters moved enactment of Council Bill 30, Draft 2; seconded by Council Member Knotts. The motion carried 9-0.

Chairman Shapiro recognized that the public hearing for Council Bill 30 had not been held prior to its enactment. Council Member Dean moved that the Council reconsider Council Bill 30 to conduct the required public hearing; seconded by Council Member Knotts. The motion carried 9-0.

Pursuant to proper notice the public hearing convened on Council Bill 30. No persons wishing to speak, the public hearing was declared held. Council Member Hendershot moved amendment number one; seconded by Council Member Harrington. The motion carried by voice vote. Council Member Hendershot moved enactment of Council Bill 30, Draft 2; seconded by Council Member Harrington. The motion carried 9-0.

CB-31-2003 – AN ACT CONCERNING SCHOOL FACILITY SURCHARGE for the purpose of increasing the amount of the School Facility Surcharge, providing for partial credits of amounts required to be paid pursuant to an adequate public facility agreement, and making other amendments concerning the School Facility Surcharge in accordance with State law. - **PUBLIC HEARING HELD; AMENDED; DR-2 ENACTED**

Council Member Harrington, as Chairman of the Planning, Zoning and Economic Development Committee, provided a verbal report of the actions and recommendation of the committee. Council Bill 31 was introduced by Council Members Shapiro, Dean, Knotts and Harrington on 5/6/2003 and favorably reported out of PZED on 6/11/2003 with recommended amendments.

Pursuant to proper notice the public hearing convened on Council Bill 31. Mr. Bob Kaufman spoke regarding the measure. All persons wishing to speak having done so, the public hearing was declared held. Council Member Harrington moved amendment number one; seconded by Council Member Dean. The motion carried by voice vote. Council Member Hendershot moved enactment of Council Bill 31, Draft 2; seconded by Council Member Dean. The motion carried 9-0.

(Public hearing held 6/10/2003; introduced by Council Members Dean, Knotts and Peters on 5/13/2003; favorably reported out of THE on 5/5/2003 with amendments)

Council Member Dean moved enactment of Council Bill 15, Draft 2; seconded by Council Member Knotts. Council Member Hendershot raised a point of order regarding the substitution of a new disclosure notice form. Ralph Grutzmacher, Legislative Officer, indicated that the legislation amends the text of the Code rather than the form; therefore, substitution of the form would not be considered a substantive amendment to the legislation. The motion carried 9-0.

Council Member Harrington moved enactment of Council Resolution 23, Draft2; seconded by Council Member Hendershot. The motion carried 9-0.
