**RESOLUTION**

1 A RESOLUTION concerning

2           The 2018 Water and Sewer Plan (December 2024 Cycle of Amendments)

3 For the purpose of changing the water and sewer category designations of properties within the  
4 2018 Water and Sewer Plan.

5           WHEREAS, Title 9, Subtitle 5 of the Environment Article of the Annotated Code of  
6 Maryland requires the County to adopt a comprehensive plan dealing with water supply and  
7 sewerage systems, established the procedures governing the preparation and adoption of said  
8 plan, and provides for amendments and revisions thereto; and

9           WHEREAS, pursuant to said procedures, the Acting County Executive submitted to the  
10 County Council her recommendations on water and sewer plan amendment requests within the  
11 December 2024 Cycle of Amendments; and

12           WHEREAS, the County Council received testimony through an advertised public hearing  
13 on the December 2024 Cycle of Amendments; and

14           WHEREAS, the County Council notified the Washington Suburban Sanitary Commission,  
15 The Maryland-National Capital Park and Planning Commission, The State and County Health  
16 Departments, the Maryland Department of Planning and the Maryland Department of the  
17 Environment of the public hearing and provided each agency with copies of the December 2024  
18 Cycle of Amendments.

19           NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's  
20 County, Maryland, that the Prince George's County 2018 Water and Sewer Plan, as adopted by  
21 CR-64-2019, and amended by CR-75-2019, CR-11-2020, CR-45-2020, CR-87-2020, CR-98-  
22 2020, CR-22-2021, CR-49-2021, CR-87-2021, CR-105-2021, CR-017-2022, CR-063-2022, CR-

1 097-2022, CR-014-2023, CR-076-2023, CR,023-2024 and CR-064-2024 is further amended by  
2 adding the water and sewer category designations as shown in Attachment A and Attachment B,  
3 attached hereto and made a part hereof.

4 BE IT FURTHER RESOLVED that the maps identified as the “Prince George’s County,  
5 Maryland, 2018 Water Map” and “Prince George’s County, Maryland, 2018 Sewer Map,” are  
6 hereby amended to incorporate the approved category changes with the property location  
7 delineated on the map in Attachment B, attached hereto and made a part hereof.

8 BE IT FURTHER RESOLVED that within five working days of the adoption of this  
9 Resolution, it shall be transmitted to the Acting County Executive by the Clerk of the Council.

10 BE IT FURTHER RESOLVED that this Resolution shall take effect on the day following  
11 the first regularly scheduled Council meeting day which occurs after the Acting County  
12 Executive indicates she has no comments, or ten working days following the transmittal of this  
13 Resolution to the Acting County Executive, whichever shall occur first. Prior to the effective  
14 date of this Resolution, the Council may reconsider its action based upon any recommendation  
15 received from the Acting County Executive.
