#### Transportation, Housing and Environment

**Date 5/10/2010**

Committee Vote: Favorable with amendments, 5-0 with Amendments (In favor: Council Members Dernoga, Turner, Harrison, Knotts and Olson)

Staff explained the purpose of CR-26-2010. The five Year Consolidated Plan for FY 2011-2015 creates a template and strategy to ensure that federal funding for housing and community development utilized to meet the goals of the County. The Consolidated Plan is a comprehensive multi-year plan for the use of funds.

The County is a recipient of funds under four Federal entitlement programs covered by the Five Year Consolidated Plan, they are Community Development Block Grant (CDBG), Home Investment Partnerships (HOME), Emergency Shelter Grant (ESG) and the Housing Opportunities for Persons with AIDS (HOPWA).

The Transportation, Housing and Environment Committee reviewed the Five Year Consolidated Plan FY2011-2016, focusing on the Counties overall goal and making sure that there was a strategy in place within the Five Year

Consolidated Plan to move the County forward.
