Staff summarized the purpose of the resolution. CR-53-2007 draft 2 concerns the Supplementary appropriations of Federal Funds for the purpose of appropriating funding from grants in the amount of \$2,646,877 to the Department of Housing and Community Development and generally relating to Housing and Community Development.

BACKGROUND INFORMATION/FISCAL IMPACT:

This supplementary appropriation of Federal funds is derived from prior fiscal year Community Development Block Grant (CDBG) funding being added to the Fiscal Year 2007-2008 Budget for CDBG funding in the amount \$2,696,877 to the Department of Housing and Development. This legislation provides the appropriation authority for the purpose of reprogramming uncommitted CDBG funds from planned projects included in the Fiscal Year 2003, Fiscal Year 2004, Fiscal Year 2005, Fiscal Year 2006, and Fiscal Year 2007 Annual Action Plans to new projects in the FY 2008 Annual Action Plan but not included in the Fiscal Year 2008 Budget.
