**Transportation, Housing and Environment** **Date 4/6/2010**  
Committee recommendations on Leadership Laurel and Mierke Property were changed by the Council today.

**Transportation, Housing and Environment** **Date 3/25/2010**  
Committee Vote: Favorable, 3-0 (In favor: Council Members Olson, Knotts and Harrison).

The August 2009 Cycle of Amendments to the 2008 Water and Sewer Plan contains Six (6) applications requesting water and/or sewer category changes.

The Committee recommended approval of the County Executive's recommendations on the following four (4) category change applications: 09/W-02 Harvey Blonder (Retain 5), 09/W-03 Divine Grace (Retain 5), 09/P-03 Mierke Property (Retain 5), 09/M-03 Curtis Farm (Retain 4).

The Committee had no recommendations of the following properties 09/W-01 Academy Place and 09/PW-02 Lasership Laurel.

**BACKGROUND INFORMATION/FISCAL IMPACT:**

The 2008 Water and Sewer Plan provides for three cycles of category change requests annually to amend the Plan. This Resolution represents the August 2009 Cycle of Amendments.

The 2008 Water and Sewer Plan was adopted by CR-91-2008, and amended by CR-17-2009 and CR-52-2009. The August 2009 Cycle contains six (6) requests for a category change.

Two (2) category change requests are in the Parkway sewershed, two (2) in the Western Branch sewershed, one (1) in the Piscataway sewershed, and one (1) in the Mattawoman sewershed.

Environment Article, Title 9, Subtitle 5, of the Maryland Annotated Code, sets procedures for amendments and revisions to the Plan. At least 30 days prior to the public hearing on the amendments, the County Council must submit to the Washington Suburban Sanitary Commission and Maryland-National Capital Park and Planning Commission a copy of the resolution for their recommendations.

4/6/2010 - CR-5-2010 was amended on the floor; DR-2 adopted.
