The presentation highlighted the following: Violent Crime Yearly Comparisons Homicides; Carjackings; Guns In Prince George's County; Overdoses; Department Services Provided; And Community First Programs - Toys For Tots, Cora Rice Christmas Party, Forensic Camp, PAL(Police Athletic League) Early youth Intervention/ Crime Prevention, Law Enforcement Explorers Program, Real Talk Sessions, Annual Backpack Giveaway- Over 800 backpacks collected and donated, Annual Coat Drive- Over 200 coats collected and donated, Annual Sock, Hat and Glove Drive- Over 15000 Socks, Hat and Gloves collected and donated, The Sock, Glove and Hat drive. Chief Aziz and his team responded to questions from Council Members.
