WHEREAS, Article III, Section 321 of the Charter for Prince George's County provides		
that the County Council, at intervals not greater than every four years, shall compile, codify,		
adopt, and publish a Code of the laws of the County in effect at such times; and		
WHEREAS	, the Zoning Ordinance was last published as the 1999 Edition; therefore	
SECTION	1. BE IT ENACTED by the County Council of Prince George's County,	
Maryland, sitting	as the District Council for that part of the Maryland-Washington Regional	
District in Prince	George's County, Maryland, that the 2003 Edition of the Zoning Ordinance of	
Prince George's	County, Maryland, being also Subtitle 27 of the Prince George's County Code	
is hereby compil	ed, codified, adopted, and published.	

- (a) On and after the effective date of this Ordinance, Subtitle 27 of the Prince George's County Code, as set out in the Zoning Ordinance of Prince George's County, Maryland, 2003 Edition, together with any current Supplement that may be issued, shall be, with respect to the matter set forth therein:
- (1) Conclusive evidence of the text of Subtitle 27 of the Prince George's County Code, together with all amendments enacted or adopted on or before November 30, 1999; and
- (2) Prima facie evidence of all Zoning text amendments enacted after November 30, 2003.
- (b) Supplements containing any changes in, or additions to, the Zoning Ordinance of Prince George's County, Maryland, being also Subtitle 27 of the Prince George's Code, 2003 Edition, shall be published at least annually.
- SECTION 2. BE IT FURTHER ENACTED that the 2003 Edition of the Zoning Ordinance of Prince George's County, Maryland, being also Subtitle 27 of the Prince George's County Code, shall take effect on the effective date of this Ordinance. The master copy of the 2003 Edition of the Zoning Ordinance shall be authenticated by the Council's Legislative Officer and delivered as a public record to the Clerk of the Council. The Clerk shall maintain that master copy together with any supplements thereto. A copy of the 2003 Edition of the Zoning Ordinance shall be made available at the County Documents Reference Library for public use during normal working hours.
- SECTION 3. BE IT FUTHER ENACTED that the general penalty provided in Section 1-123 of the County Code shall apply to every offense or violation made unlawful by the Zoning Ordinance of Prince George's County, Maryland, being also Subtitle 27 of the Prince George's County Code, unless a specific penalty therefore is otherwise provided.
- SECTION 4. BE IT FURTHER ENACTED that this is Ordinance shall take effect on the date of its adoption.
