PLANNING, ZONING & ECON. DEV. COMMITTEE REPORT 10/14/03

Committee Vote: Favorable, 5-0 (In favor: Council Members Harrington, Dernoga, Dean, Exum and Knotts)

The committee discussed CB-88-2003 simultaneously with CR-61-2003, a companion resolution transferring appropriations and expenditures between two development projects in the Approved Maryland-National Capital Park and Planning Commission's (M-NCPPC) FY2003-2004 Capital Budget and Fiscal Years 2004-2009 Capital Improvement Program (CIP).

CB-88 amends the M-NCPPC FY2004 Capital Budget and FY2004-2009 CIP to add a new development project to be entitled the Bowie Civic Auditorium in the Commission's Fiscal Year

2004 Capital Budget. CR-61-2003 provides for the transfer of \$1.1 million from the District 4 Development Reserve to the new project in Fiscal Year 2004.

Council Member Peters, the bill's sponsor, explained that CB-88 and CR-61 designate funds from the District 4 Development Reserve to a specific project, the Bowie Civic Auditorium.

The Legislative Officer determined that the bill is in proper legislative form. The Office of Audits and Investigations determined there should be no negative fiscal impact on the County as a result of enacting CB-88-2003.

BACKGROUND INFORMATION/FISCAL IMPACT

This Bill would, in accordance with Section 2-118 of Article 28 of the Annotated Code of Maryland, amend the Maryland-National Capital Park and Planning Commission FY 2004 Capital Budget and FY 2004-2009 CIP. This amendment adds a new development project to be entitled the Bowie Civic Auditorium in the Commission's Fiscal Year 2004 Capital Budget. A companion resolution (CR-61-2003) provides for the transfer of \$1.1 million from the District 4 Development Reserve to the new project in Fiscal Year 2004.
