## LEGISLATIVE HISTORY

FISCAL AND PLANNING COMMITTEE REPORT DATE: March 5, 1990

Committee Vote: Favorable, as amended 4-0 (In favor: Council Members Castaldi, Casula, Pemberton and Wineland)

This legislation will provide supplementary appropriations to various departments and agencies for costs which were not provided for in the approved fiscal year 1990 Current Expense Budget. It increases the General Fund by a total of \$10,295,294. These funds come from prior year available and uncommitted fund balance.

The supplemental fund is distributed as follow: \$4,405,741 - cover the COL increases for union employees 233,332 - COL for Memorial Library \$4,639,073 500,000 - Mass Transit Fund (WMATA for Metrobus

\$5,139,073 service and expanded local bus services) In the Non-Departmental Accounts the amount of \$5,156,221 is being appropriated to the following: \$224,261 - Debt Service cost for interest payments on Parking Authority bond (Hyattsville parking facility) 1,333,486 - Self-Insurance Funds for Risk Management 3,563,474 - Fringe Benefits (Social Security, Retirement and 5,121,221 Life Insurance costs related to negotiated agree Life Insurance costs related to negotiated agreements and COL adjustment for Union Employees) 35,000 - Grants and transfers to fund the addition of 5,156,221 College Park to the State Police Aid Program The total cost for Union contracts is \$7,769,215 \$4,405,741 - Supplemental COL 3,563,474 - Fringe Benefits (Non-Department) 7,969,215 The amount transfered from the Contingency Fund to various departments: \$1,202,978 - COL for general schedule employees 1,262,990 - Lease-purchase agreement (semi-annual payment) 2,465,968 33.4 million - Total fund balance for FY89 10.3 million - CB-21-1990 22.0 million - amount remaining in fund balance after deducting supplementary appropriation The following union contracts have been approved by the County Council: American Federation of State, County and Municipal (1)Employees (AFSCME) AFL-CIO) (2) Fraternal Order of Police Lodge #89 (3) School Crossing Guards

The Legislative Officer and the Office of Law have found this legislation to be in proper form with no legal impediments to its adoption.

The Office of Finance has certified in writing that \$10,295,294 is available from unappropriated and available fund balance and \$2,465,968 from Contingency Funds for supplementary appropriations to various County agencies in the General Fund.
