WHEREAS, CB-54-199	7 adopted and enacted the Annual Budget and Appropriation
Ordinance of Prince George's	County for Fiscal Year 1997-1998, which sets forth the amount of
appropriations and revenue est	cimates, said appropriation and revenue estimates to be adjusted as
hereinafter set forth; and	
WHEREAS, pursuant to	Section 819 of the Charter for Prince George's County, Maryland,
the County Council, may upor	recommendation of the County Executive, make additional or
supplementary appropriations	from revenues received from anticipated sources but in excess of
budget estimates therefore, fro	m revenue received from sources not anticipated in the budget for
the current year and from any	prior year available and uncommitted fund balances, provided that
the Director of Finance shall f	irst certify in writing that such funds are available for such
appropriation; and	
WHEREAS, an agency of	f the County government requires additional appropriations as
provided herein, and certain ac	dditional revenues have been identified; and
WHEREAS, the County	Executive has duly recommended that the supplementary
appropriations be made; and	

WHEREAS, the Director of Finance has certified in writing that additional revenues are

available for such supplementary appropriation; now, therefore

SECTION 1. BE IT ENACTED by the County Council of Prince George's County, Maryland, that the following adjustments to revenue estimates for the Fiscal Year 1997-1998 Current Expense Budget as expressed in CB-54-1997 for the General Fund are made:
