disapprove the app	pointment within thirty (30) days after the County Executive submits the name
of the appointee to	o the County Council; and
WHEREAS,	Section 15-103(b)(4) requires that the resolution for each appointment
describe the result	ting geographic distribution and provide appropriate explanations; and
WHEREAS,	the County Executive has duly nominated Dorothy F. Bailey, a resident of
Temple Hills, to s	erve as a member of the Maryland-National Capital Park and Planning
Commission of th	e Prince George's County Planning Board; and
WHEREAS,	a public hearing on the appointment of Dorothy F. Bailey to the Commission
has been held befo	ore the County Council; and

1	WHEREAS, the remaining four (4) members of the Commission from Prince George's
2	County are residents of Bowie, Fort Washington, Mitchellville, and University Park,
3	respectively.
4	NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's
5	County, Maryland, sitting as the District Council for that part of the Maryland-Washington
6	Regional District in Prince George's County, Maryland, that, as a result of appointment of

9	of residence of the members of the Commission from Prince George's County.
