1. **BILLS ELIGIBLE FOR THIRD READING (ENACTMENT)**

**CB-94-2013 (DR-2) - AN ACT CONCERNING LABOR – MINIMUM WAGE** for the purpose of specifying the amount of the County minimum wage rate that is in effect for certain time periods and generally relating to the payment of wages. - **AMENDED; DR-3 ENACTED**

(Public hearing held 11/19/2013; introduced by Council Members Turner, Davis, Franklin, Harrison, Lehman, Olson, Patterson and Toles on 10/22/2013; favorably reported out of PSFM on 10/17/2013 with amendments)

*A motion was made by Council Member Olson, seconded by Council Member Davis, that this Council Bill be amended. Colette Gresham, Legislative Officer, gave an overview of the six amendments to be proffered. The motion carried 6-0 (Absent: Council Members Campos, Patterson and Toles). A motion was made by Chairman Franklin, seconded by Council Member Davis, that this Council Bill be enacted. Under discussion, Council Members Lehman, Franklin, Olson, Davis, Turner and Harrison expressed the reasons for their support of this measure. The motion carried 7-0 (Absent: Council Members Campos and Patterson).*
