Council Bill 14 amends the use table to allow townhouses in the R-R Zone under certain circumstances. Council Bill 14 was favorably reported out of Planning Zoning and Economic Development (PZED) Committee on April 7,2004 with amendments. Council Bill 14 was introduced by Council Members Harrington and Dean.

<u>CB-16-2004 – AN ORDINANCE CONCERNING AMENDMENTS TO</u> <u>APPROVED BASIC PLANS</u> for the purpose of authorizing amendments to approved Basic Plans under certain circumstances. - <u>INTRODUCED</u>

Council Bill 16 would authorize the streamlined amendment of an approved Basic Plan for the purpose of accommodating a "Planned Environmental Preservation Community." A Planned Environmental Preservation Community was defined by CB-35-2003. Council Bill 16 was favorably reported out of Planning, Zoning and Economic Development Committee (PZED) on April 7, 2004. Council Bill 16 was introduced by Council Members Dean, Exum, Harrington and Peters.

Council Member Hendershot requested clarification of related legal issues. Kathy Canning Associate Council Attorney and Ralph Grutzmacher, Legislative Office, provided comments.
