**ZONING BILL**

1 AN ORDINANCE concerning

2 Subtitle 27 – The Zoning Ordinance

3 For the purpose of adopting and publishing the 2023 Edition of the Zoning Ordinance of Prince  
4 George’s County, Maryland, being also Subtitle 27 of the Prince George’s County Code.

5 BY compiling, codifying, adopting, and publishing:

6 The Zoning Ordinance of Prince George's County, Maryland,

7 being also

8 SUBTITLE 27. ZONING.

9 The Prince George's County Code

10 (2023 Edition).

11 WHEREAS, Article III, Section 321 of the Charter for Prince George’s County provides  
12 that the County Council shall compile, codify, adopt, and publish a Code of the laws of the  
13 County in effect at such times at intervals not greater than four years; and

14 WHEREAS, the Zoning Ordinance for Prince George’s County, Maryland, being also  
15 Subtitle 27 of the Prince George’s County Code, was last published as the 2019 Edition; now,  
16 therefore,

17 SECTION 1. BE IT ENACTED by the County Council of Prince George's County,  
18 Maryland, sitting as the District Council for that part of the Maryland-Washington Regional  
19 District in Prince George's County, Maryland, that the 2023 Edition of the Zoning Ordinance of  
20 Prince George's County, Maryland, being also Subtitle 27 of the Prince George's County Code,

1 be and the same is hereby compiled, codified, adopted, and published.

2 (a) On and after the effective date of this Ordinance, Subtitle 27 of the Prince George’s  
3 County Code, as set out in the Zoning Ordinance of Prince George’s County, Maryland, 2023  
4 Edition, together with any current Supplement that may be issued, shall be, with respect to the  
5 matter set forth therein:

6 (1) Conclusive evidence of the text of Subtitle 27 of the Prince George’s County Code,  
7 together with all amendments enacted or adopted on or before November 30, 2019; and

8 (2) Prima facie evidence of all Zoning text amendments enacted after November 30,  
9 2023.

10 (b) Supplements containing any changes in, or additions to, the Zoning Ordinance of  
11 Prince George’s County, Maryland, being also Subtitle 27 of the Prince George’s County Code,  
12 2023 Edition, shall be published annually.

13 SECTION 2. BE IT FURTHER ENACTED that the 2023 Edition of the Zoning Ordinance  
14 of Prince George’s County, Maryland, being also Subtitle 27 of the Prince George’s County  
15 Code, shall take effect on the effective date of this Ordinance. The master copy of the 2023  
16 Edition of the Zoning Ordinance shall be authenticated by the Council’s Legislative Officers and  
17 delivered as a public record to the Clerk of the Council. The Clerk shall maintain that master  
18 copy together with any supplements thereto. A copy of the 2023 Edition of the Zoning Ordinance  
19 for Prince George’s County, Maryland, being also Subtitle 27 of the Prince George’s County  
20 Code, shall be made available in the Office of the Clerk of the Council for public use during  
21 regular business hours.

22 SECTION 3. BE IT FUTHER ENACTED that the general penalty provision provided in  
23 Section 1-123 of the Prince George’s County Code shall apply to every offense or violation  
24 made unlawful by the Zoning Ordinance of Prince George’s County, Maryland, being also  
25 Subtitle 27 of the Prince George’s County Code, unless a specific penalty therefor is otherwise  
26 provided by law.

27 SECTION 4. BE IT FURTHER ENACTED that this Ordinance shall take effect forty-five  
28 (45) calendar days after its adoption.
