**BACKGROUND INFORMATION/FISCAL IMPACT:**

General Fund Revenue Changes:

This legislation provides additional appropriation authority totaling \$70,018,000 in the General Fund. The additional resources will increase the Fiscal Year 2026 General Fund Budget from \$4,815,950 as expressed in CB-56-2025 and amended in CB-098-2025 to \$4,826,316,900. The legislation appropriates additional Miscellaneous M-NCPPC (“Maryland-National Capital Park and Planning Commission”) (\$13,060,000) and Real Property Tax - General (\$56,958,000) as revenue sources.

M-NCPPC Special Grants

This legislation increases appropriation for several agencies to reflect a pending memorandum of understanding between the County and M-NCPPC which distributes special grant funding to the County for a total of \$13,060,000.
