WHEREAS	the citizen participation plan was adopted by CR-26-2010 and provided for			
citizen involvement in the various stages of Housing and Community Development activities and				
listed the actions which are subject to the citizen participation plan; and				
WHEREAS	pursuant to Section 15A-105(a)(2) of the County Code, the FY 2004, FY			
2006, FY 2007, FY 2008, FY 2009, FY 2010, FY 2011, and FY 2012 Annual Action Plans must				
be amended to in	lude the estimated cost of projects, the total cost to bring them to completion,			
and an identifica	on of the sources of funds; and			
WHEREAS	Attachment "A-1" includes the projects within CDBG Program Years 35, 36,			
and 37 (i.e., FY 2010, FY 2011, and FY 2012) that were approved in prior Annual Action Plans				

and that need to be restructured; and

WHEREAS, Attachment "A-2" includes the projects within CDBG Program Years 29, 31, 32, 33, 34, and 35, (*i.e.*, FY 2004, FY 2006, FY 2007, FY 2008, FY 2009, and FY 2010) that were approved in prior Annual Action Plans and that need to be reprogrammed and reallocated to new activities; and

WHEREAS, Attachment "A-3" includes the projects within ESG Program Year 24 (*i.e.*, FY 2012) that were approved for the first allocation in a prior Annual Action Plan and that need to be restructured and the use of the second allocation of ESG funding; and

WHEREAS, Attachment "B" draft FY 2012 Annual Action Plan, as amended, includes the new ESG narrative requirements that apply to the Annual Action Plan and future submissions for receiving ESG funds.

NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's County, Maryland, that the Prince George's County FY 2004, FY 2006, FY 2007, FY 2008, FY 2009, FY 2010, FY 2011, and FY 2012 Annual Action Plans for Housing and Community Development are hereby amended to restructure, reprogram and approve CDBG and ESG activities related to housing and community development, and add new ESG narrative requirements that apply to the Annual Action Plan and future submissions for receiving ESG funds, as described in Attachments "A-1, A-2, A-3, and B".

BE IT FURTHER RESOLVED that upon adoption of the Resolution, it shall be transmitted to the County Executive by the Clerk of the Council to submit the amended Annual Action Plans to the U.S. Department of Housing and Urban Development.
