Committee Vote: Favorable, 5-0 (In favor: Council Members Dernoga, Bland, Dean, Exum, and Harrington)

This legislation would permit uses, by right or by special exception, in the I-1 Zone to be allowed in the I-3 Zone, if the I-3 property meets certain criteria. The property must include 60 or more acres, adjoin a railroad right-of-way, and adjoin I-1 and I-2 property.

The Principal Counsel found the bill to be in proper legislative form. The Planning Board opposes CB-92-2004 indicating that many I-1 uses are not compatible with uses in the I-3 Zone nor serve the purposes of the zone as it applies to adjoining I-3 zoned land.

The Office of Audits and Investigations determined there should be no negative fiscal impact on the County as a result of enacting CB-92-2004.

The Longwood Community Association submitted a letter dated June 14, 2004, to Chairman Dernoga expressing

support for an I-1 light industrial complex in the Muirkirk corridor.
