readily accessible to the County Council.

### **BACKGROUND INFORMATION/FISCAL IMPACT:**

This bill will require the Office of Central Services to maintain the employment metrics of contractors and subcontractors that are awarded construction contracts of one million dollars (\$1,000,000.00) or more with the County, and have the Director of the Office of Central Services submit an annual report to the County Executive and County Council each year by July 1. The annual report will aid the County Executive and County Council in assessing the contractors' minority business enterprise participation.
