**BILL**

1 AN ACT concerning

2 The Classification Plan for Prince George's County

3 For the purpose of adding certain existing classes of work to the Deputy Sheriff's Association of  
 4 Prince George's County, Inc. (DSA) (Civilian Units) Salary Schedule "Z".

5 WHEREAS, the County Executive, pursuant to Section 903 of the Prince George's County  
 6 Charter and Section 16-125(a) of Subtitle 16 of the Prince George's County Code, has, in order  
 7 to provide better governmental services, recommended to the County Council amendments to the  
 8 Classification Plan for Prince George's County, Maryland with respect to certain classes of work  
 9 described within Section 1 of this bill, in accordance with the Certification of Representation  
 10 issued by the Prince George's County Public Employee Relations Board (PERB) in Case Number  
 11 16 39 00 196 92DS and Case Number 16 39 00197 92DS for positions in the bargaining unit  
 12 represented by Deputy Sheriff's Association of Prince George's County, Inc. (DSA) (Civilian  
 13 Units) now, therefore,

14 SECTION 1. BE IT ENACTED by the County Council of Prince George's County,  
 15 Maryland, that the Classification Plan for Prince George's County, Maryland be and the same is  
 16 hereby amended as follows:
