**SUBDIVISION BILL**

1 AN ACT concerning

2 Subtitle 24, Subdivisions

3 For the purpose of adopting and publishing Subtitle 24, Subdivisions, of the 2015 Edition of the  
 4 Prince George's County Code.

5 BY compiling, codifying, adopting, and publishing:

6 SUBTITLE 24. SUBDIVISIONS.

7 The Prince George's County Code

8 (2015 Edition).

9 WHEREAS, Article III, Section 321 of the Charter for Prince George's County provides  
 10 that the County Council shall compile codify, adopt, and publish a Code of the laws of the  
 11 County at intervals not greater than four years; and

12 WHEREAS, the County Code was last published as the 2011 Edition; now, therefore,

13 SECTION 1. BE IT ENACTED by the County Council of Prince George's County,  
 14 Maryland, that Subtitle 24 of the Prince George's County Code be and the same is hereby  
 15 compiled, codified, adopted, and published.

16 (a) On and after the effective date of this Act, Subtitle 24 as set out in the Prince George's  
 17 County Code, 2015 Edition together with any current Supplement to the County Code that may  
 18 be issued, shall be, with respect to the matter set forth therein:

19 (1) Conclusive evidence of the text of Subtitle 24, Subdivisions, Prince George's  
 20 County Code and all enactments dated on or before November 30, 2011.

1           (2) Prima facie evidence of the contents of Subtitle 24, Subdivisions, Prince George's  
2 County Code (2015 Edition).

3           (b) Supplements containing any changes in or additions to Subtitle 24 of the Prince  
4 George's County Code, 2015 Edition, shall be published annually.

5           SECTION 2. BE IT FURTHER ENACTED that Subtitle 24 of the 2015 Edition of the  
6 Prince George's County Code shall take effect on the effective date of this Act. The master copy  
7 of Subtitle 24 of the 2015 Edition of the Code shall be authenticated by the Council's Legislative  
8 Officers and delivered as a public record to the Clerk of the Council. The Clerk shall maintain  
9 said master copy together with any supplements thereto. A copy of the 2015 Edition of the Code  
10 containing Subtitle 24 shall be available in the office of the Clerk of the Council for public use  
11 during regular business hours.

12           SECTION 3. BE IT FURTHER ENACTED that the general penalty provision provided in  
13 Section 1-123 of the County Code shall apply to every offense or violation of Subtitle 24 made  
14 unlawful by the County Code unless a specific penalty therefor is otherwise prescribed by law.

SECTION 3. BE IT FURTHER ENACTED that this Act shall take effect thirty (30) calendar days after it becomes law.
