AN ACT concerning

A Revenue Adjustment

FOR the purpose of appropriating to the Board of Education an amount of \$3,516,000 from prior year available and uncommitted fund balance for the purpose of replacing federal assistance budgeted but not received in the Approved Fiscal Year 1989-1990 Budget.

WHEREAS, Council Bill 91-1989 adopted and enacted the Annual Budget and Appropriation Ordinance of Prince George's County for Fiscal Year 1989-1990, which sets forth the amount of appropriations and revenue estimates, said revenue estimates to be adjusted as hereinafter set forth; and

WHEREAS, under the provisions of Section 819 of the Charter for

Prince George's County, Maryland, the County Council, upon recommendation of the County Executive, may make additional or supplementary appropriations from revenue received from anticipated sources but in excess of the budget estimates therefore, from

revenues received from sources not anticipated in the budget for the current fiscal year and from any prior year available and uncommitted fund balance; and

WHEREAS, funds are required by the Board of Education to replace federal assistance for the Magnet School Program, budgeted but not received in the Approved Fiscal Year 1989-1990 Budget; and

WHEREAS, the Director of Finance has certified in writing that such funds are available for such transfer; and

WHEREAS, the County Executive has duly recommended that the transfer of uncommitted fund balance be made; therefore

SECTION 1. BE IT ENACTED by the County Council of Prince
George's County, Maryland, that the following adjustments to revenue
estimates in the Fiscal Year 1989-1990 Approved Current Expense
Budget for the General Fund as expressed in Council Bill 91-1989;
are made:

SECTION 2. BE IT FURTHER ENACTED that a transfer of fund balance in the amount of \$3,516,000 is hereby made to the Board of Education.

SECTION 3. BE IT FURTHER ENACTED that this Act shall take effect forty-five (45) calendar days after the day it becomes law

and that the provisions of Sections 1 and 2 of this Act shall be retroactively effective to June 30, 1990.
