BACKGROUND INFORMATION/FISCAL IMPACT:

The proposed legislation is amending Subtitle 10A of the Prince George’s County Code. The amends would clarify sections regarding administrative procedures, award of contracts, special provisions and economic development.

10/17/2017: Prior to introduction, CB-115-2017 (DR-2) was amended on the floor as follows:

On page 11, line 25, add “The report shall include the number and nature of the waivers for contracts over Five Hundred Thousand Dollars (\$500,000) approved by the Chief Administrative Officer pursuant to 10A-159.01.”

CB-115-2017 (DR-3) was introduced.
