Dear Mr. Donahue:

This joint signature letter endorses the Prince George's County Board of Education's proposed FY2027 capital budget request and identifies the projects that Prince George's County considers most critical. This funding endorsement is consistent with the priorities of Prince George's County for public education and the modernization of our extensive and aging portfolio of school facilities.

The Board's FY2027 State funding request of \$65.6M balances major school modernization projects with smaller initiatives that address programmatic needs tied to the Blueprint for Maryland's Future legislation. Additionally, this year's request includes critically needed envelope projects, such as window and roof replacements, which are typically excluded from State funding requests. By including these projects, Prince George's County ensures its role in the requested State-wide expression of need, maximizes potential CIP funding, and prepares for any additional dollars that may be identified, helping to close funding gaps and secure the maximum possible support.

1 – Continuation Request for Multi-Year Modernizations

This first priority group is for continued State funding for multi-year modernizations and new schools that have received State planning approval and/or prior year construction funding. They include the request of funding support for the modernization of William Schmidt Outdoor Education Center and the replacements of the Cool Spring/Adelphi Elementary, High Point High and the new Northern Adelphi Area High.

2 – Requests for Planning Approval

The second priority group consists of requests for Planning funds for two projects that will support the pre-k and Career & Technical Education (CTE) expansion mandates of the *Blueprint for Maryland's Future*: the Riverdale Hills PreK will provide 200 seats for 3 year-old and 4 year-old prekindergarten students and the Crossland High CTE addition project will increase the access of students to skills training that can lead to employment and enhance the workforce capacities of the county.

3 – Requests for Envelope Replacement Projects

The final priority group projects are included specifically for the funding gap resolution mentioned above but truly address some of the most critically needed project types in our inventory: systemic roof and window/door replacements. These projects ensure and sustain (or remedy) the safety and healthiness of our older buildings in preventing water infiltration and the hosts of issues it causes from mold to structural decay.

4 – Future Year Requests

For future years, Prince George's County Public Schools will undertake the next set of Cycle 1 modernization projects that were identified in the Master Plan Support Project (MPSP) in 2014 and the approved Educational Facility Master Plan (EFMP) in FY2017. The required update study for Cycle 2 prioritization has already begun in Fall 2025 with the renewal of Educational Specifications and in Spring the commencement of the full study of all remaining facilities. The next projects for execution include:

New Southern Area ES (Consolidation Schools TBD) (Final project selection will be drawn from the highest-need schools identified based on condition and educational space deficits in the approved FY17 EFMP, with formal confirmation by the Board anticipated in Spring 2026)
New Southern Area MS (TBD)
Longfields Elementary Phased Renovation (Limited Renovation)
Calverton Elementary Phased Renovation (Limited Renovation)
Largo High School

The County Government supports the Board's sequentially prioritized FY 2027 State and County funding request and remains prepared to continue to provide significant local resources for school facilities.
