Dear Chair Dernoga,

It is my pleasure to submit to you and the County Council the appointments of Ms. Pamela D. Jenkins and Mr. Kelly Porter to the Historic Preservation Commission for Prince George's County. The Commission's powers and duties, as provided in Section 29-106 of the County Code include: recommending historic resources for classification at Historic Sites or Historic Districts, maintaining an inventory of historic resources, acting on applications for Historic Area Work Permits and recommending legislation to encourage historic preservation.

As per the statute that governs the membership of the Historic Preservation Commission, three members "shall possess a demonstrated special interest, specific knowledge or professional or academic training in such fields as history, architecture, architectural history, archeology, anthropology, agriculture and historic preservation" (hereafter "background in historical fields"), three members shall "represent the fields of commerce, realty, municipal governance, community associations, building/preservation restoration, home building and law" (hereafter "background in commerce and community"), one member shall be selected from the Prince George's County Historic and Cultural Trust Board, one member shall be selected from the Minority Building Industry Association and one member shall be selected from the County's Board of Realtors.

Ms. Pamela D. Jenkins, a resident of Bowie, is an award willing Licensed Realtor and a board member of the Prince George's County Association of Realtors (PGCAR). She provides guidance and assist individuals in purchasing property for the best value at the best terms while performing comparative analyses. Ms. Jenkins was also an Adjunct Professor at Prince George's Community College Center for Entrepreneurial Development. She received her undergraduate degree in Business Administration form Columbia Union/Washington Adventist University and her Master of Business Administration in Global Management from the University of Phoenix.

Mr. Kelly Porter, a resident of Seat Pleasant, serves as the Honorable Mayor of the Town of Seat Pleasant and has served on the City Council since 1996. In this role, he provides leadership while developing, implementing, and evaluating city government initiatives and programs. He brings

decades of strategic planning, budget management, public administration, and economic development experience. Mr. Porter is a Librarian Assistant in Montgomery County, is employed by Giant Food and is also a realtor. He received his Bachelor of Science degree in Business Administration from State University of New York.
